

**EXHIBIT B - Authorization Form**

I, \_\_\_\_\_, have provided the information contained in the pedigree chart and accompanying audio and/or video recording regarding the content of the pedigree chart ("Recording"), and digital images ("Digital Images") of original records and photographs ("Original Records") (collectively, the "Pedigree"), and declare that the information I provided is accurate to the best of my knowledge. Further, I:

1. represent and warrant that I have been informed of and understand the purposes for which FamilySearch International ("FamilySearch") is collecting the Pedigree and all personal identifying information contained therein;
2. agree and acknowledge that I have authorized the creation of, and the use of my image and/or voice therein, in the Recording, and that I will not receive any compensation for any rights or licenses granted or any grant of additional rights as outlined herein;
3. hereby grant permission to FamilySearch to collect, maintain and transfer to the United States of America or any other country, which may have less stringent data privacy laws than the country where I reside, the Pedigree and all personal identifying information contained therein, in order to preserve and store the Pedigree and personal identifying information, and allow FamilySearch to identify me and administer the uses of the Pedigree described herein. I consent to this collection, use, processing, disclosure and transfer of personal identifying information for the purposes described herein, and allow FamilySearch to maintain such personal identifying information for as long as necessary to meet the above purposes;
4. understand that I have the right to refuse to consent to FamilySearch collecting and using my personal identifying information as outlined herein, and that providing my personal identifying information is optional and voluntary, but that if I decline to provide consent that my personal identifying information may not be included in the Pedigree, which likely will limit my ability (as well as the ability of others) to conduct genealogical research on FamilySearch's website;
5. understand that once I submit my personal identifying information to FamilySearch that I have the right to access, verify, correct, or remove my personal identifying information by contacting FamilySearch International through its data privacy officer for The Church of Jesus Christ of Latter-day Saints at: [dataprivacyofficer@ldschurch.org](mailto:dataprivacyofficer@ldschurch.org);
6. represent and warrant that for any personal identifying information that I have provided about persons other than myself that are still living ("Third Parties"), which is contained in the Pedigree, including the Recording, Digital Images, and Original Records, I have obtained informed consent from the Third Parties to disclose that information to FSI and to use their personal identifying information for the purposes described herein;
7. represent and warrant that: (A) I have authorized the digital copying of the Original Records and creation of the Digital Images; (B) I have the authority, powers and/or any necessary authorizations or licenses to agree to and grant the rights for the digital copying of the Original Records and creation of the Digital Images; and (C) the Original Records (i) were legitimately acquired by me, (ii) are original records, and (iii) do not infringe any third-party rights;
8. hereby grant to FamilySearch a royalty-free, irrevocable, worldwide, non-exclusive, transferable license to publish, reproduce, modify, adapt, translate, create derivative works from, distribute, perform, display, and use the Pedigree, or any part thereof, perpetually and on a definitive basis, for any lawful purpose, without limitation, including publication or exhibition on the Internet for full public access so that FamilySearch and its users, licensees, successors, assigns, and affiliated entities can access and download for genealogical research purposes; and FamilySearch's creation of derivative works (including electronic indices);
9. represent and warrant that I have the authority, power and/or any necessary authorizations or licenses to agree to and grant to FamilySearch all foregoing rights set forth in paragraph 8; and
10. represent and warrant that the contents of this form have been clearly and correctly explained to me in a language that I understand and that I fully comprehend the contents of this form.
